Pursuant to the Administrative Department's letter No: ME/NG//80//2021-02 dated 15-07-2021 and the clearance from J&K Service Selection Board, Jammu vide Order No: 226 - SSB of 2021 Dated: 08-06-2021 and, after receiving the CID verification from Criminal Investigation Department Jammu and Kashmir, sanction is hereby accorded to the temporary appointment of Mr. Mohd Danish S/o Abdul Qayoom R/o Peer Mitha, Jammu under Open Merit, against the post of "Clinical Staff for Casualty Bed" in the Govt. The appointment of the above named candidate shall be subject to the following conditions:

The appointee shall be allowed to join only on the production of following certificates in original:

- i. **Date of birth certificate**
- ii. **Qualification certificates**
- iii. **Domicile Certificate**
- iv. **Health certificate**
- v. **Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.**
- vi. **Relevant category certificate, if applicable.**
- vii. **Any other documents as required under rules.**
- viii. **Affidavit from 1st Class Magistrate.**

2. The appointment of candidate is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.

3. The salary of the appointees shall not be drawn and disbursed to him unless the verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
4. The appointment of these candidates shall be governed by **S.O 194 of 2020**.
5. The appointee shall be governed by the "**New Pension Scheme**" as notified vide **SRO-400 of 2009 dated 24-12-2009**.
6. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
7. The appointment of the selected candidate shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
8. The inter-seniority of the above appointee shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.

If the candidate fails to join this office within the stipulated time period of 21 days he shall forego right of appointment which shall be deemed to have been cancelled ab-initio without any further notice as per the instructions issued by the Gen. Administration Department vide circular No.08-JK(GAD) of 2019 dated 04-12-2019.
