Subject:- Engagement of Mr. Yassar Khan as Tutor in Govt. Nursing College, Kishtwar in terms of SO 364 of 2020.

Sanction is hereby accorded to the engagement of **Mr. Yassar Khan S/o Late Sarrefraz Khan R/o Marmat Doda** in Govt. Nursing College, Kishtwar on tenure basis for a period of one year extendable upto Six years in terms of SO 364 of 2020.

The engagement of the Tutor shall, however be subject to the following terms and conditions:

1. The above said Tutor is directed to report Principal, Government Medical College, and Doda within 7 days after the date of issuance of this engagement order along with all the following certificates in original and three photocopies of each of them.
 - i. **Date of birth certificate.**
 - ii. **Qualification certificates.**
 - iii. **Domicile Certificate issued by the competent authority.**
 - iv. **Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.**
 - v. **Any other documents as required under rules.**
2. The tenure of **Tutor** shall be subject to work and conduct of the **Tutor** in Govt. Nursing College, Kishtwar remaining satisfactory during his tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the college / students/ academic / curricular / co-curricular activities, the tenure engagement of tutor shall be terminated without any notice.
3. The **Tutor** shall be asked to give an undertaking to the effect that he has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before he is allowed to join. He shall submit his joining report to the Principal, Government Medical College, and Doda only after a formal letter is sent to him after ensuring that all the requisite formalities have been completed.
4. The **Tutor** shall be asked to give an undertaking to the effect that if his academic qualifications / degrees during verification turns to be adverse, the services of the above named tutor shall be terminated forthwith.

5. If Tutor intends to leave the job, he/ she shall have to provide one month's prior notice duly forwarded by the Principal ANM School, Kishtwar or shall have to deposit one month's salary in this institution. Further, one month's salary of appointees shall be kept withheld as security.
6. No experience certificate will be issued before completion of tenure of one year.
7. The above engagements shall be without prejudice to the outcome of Writ Petition(s), if any, pending consideration before the Court(s) of competent jurisdiction.
